On 4 August 2011 the Government amended the anti-siphoning list to remove the recent Rugby Tri-Nations matches between Australia and New Zealand, to allow the Nine Network to premiere these events on its multi-channels. On 3 August 2011 the UK Government announced plans to modernise UK intellectual property laws. Ministers have accepted the recommendations made in an independent review which estimate a potential benefit to the UK economy of up to £7.9 billion. Live odds in sports broadcasts

The Government is in consultation with industry stakeholders regarding next steps to implement the Council of Australian Government Select Council on Gambling Reform announcement of 27 May 2011 on reducing and controlling the promotion of live odds during sports broadcasts.

Digital switchover

The Government has set the switchover date for the Southern NSW and Griffith television licence areas as 5 June 2012. The relevant legislative instrument and explanatory statement is available here: <u>http://www.comlaw.gov.au/Details/F2011L01767</u>

The latest Digital Tracker survey reports that 82 per cent of households nationally have converted to terrestrial digital TV. Darwin has the highest conversion rate of 89 per cent at the end of June, with Tasmania next on 86 per cent, Adelaide 85 per cent, northern New South Wales 84 per cent, and southern New South Wales 83 per cent. The Digital Switchover Taskforce's Digital Tracker Summary Report for Quarter 2 (April-June 2011) showed that in regional Queensland (scheduled for switchover on 6 December 2011) 84 per cent had converted by the end of June 2011, up from 46 per cent in early 2009.
